#### **Implementation Prep**



- Frequency of cross-functional team meetings
- Teams represented
- Approach for selecting classrooms to convert
  - Staffing vacancies drove some final decisions
  - Tenure of staff
  - Facility factors

#### **Implementation Prep**



- Other staffing considerations as a result of conversion
  - Revised number of children and families by school
  - Adjusted assignments for service areas
- Communication w/ Part C and LEA partners
  - Referrals to public schools
  - Referrals from SoonerStart
